#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Arlington School District No. 16 from September 1, 2021 through August 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2023 and 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Associated Student Body activities at Arlington High School and Weston High School fundraisers and compliance with House Bill 1660
- Accounts payable credit cards
- Student enrollment reporting basic enrollment and special education
- Use of restricted funds professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Payroll gross wages
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### **INFORMATION ABOUT THE DISTRICT**

Arlington School District No. 16 provides education services to students in preschool through 12th grade. The District's service area includes the City of Arlington and neighboring unincorporated portions of Snohomish County. The District serves nearly 5,420 students with a staff of approximately 355 certificated, 329 classified, and 30 administrative employees. The District operates two high schools, including one choice high school, two middle schools, four elementary schools and one K-12 Alternative Learning Experience (ALE) Program.

An elected, five-member Board of Directors governs the District. For fiscal year 2023, the District expended approximately \$94,650,686 million
