AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Charter Public School operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Impact-Commencement Bay Elementary from September 1, 2022 through August 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Charter Public School's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended August 31, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Use of restricted funds – professional learning and local revenue for enrichment activities
- Compliance with supplemental contracts for enrichment activities
- Open public meetings – compliance with minutes, meetings, and executive session requirements
- Accounts Payable – general disbursements, credit cards, travel expenditures
- Procurement – professional services
- Tracking and monitoring of theft sensitive assets, such as computers, tools, equipment
- Student enrollment reporting – special education

INFORMATION ABOUT THE CHARTER PUBLIC SCHOOL

Impact-Commencement Bay Elementary, located in Pierce County, provided educational services to about 260 students in grades K-1 during the 2022-2023 school year.

The Charter Public School is a 501(c)(3) nonprofit corporation established under RCW 28A.710.020 and governed by a two to nine member appointed Board of Directors that establishes policies for the Charter Public School according to the terms of a renewable, five-year charter contract executed under RCW 28A.710.160.

Impact Public Schools is authorized by Washington State Charter School Commission to operate Impact-Commencement Bay Elementary by a five-year contract effective August 23, 2021, and terminating August 23, 2026.

The Charter Public School received about \$5.0 million in direct state and federal funding for fiscal year 2022-2023. The Charter Public School operated in one building and employed about 30 employees in the 2022-2023 school year.
