AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Department operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to authorization of purchase card payments and commercial lease billings that we communicated to Department management and the Commissioner in a letter dated August 29, 2024. We appreciate the Department's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Department of Natural Resources from July 1, 2022 through June 30, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the Department's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended June 30, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Purchase card payments
- Cash receipting
- Noncapitalized assets, supplies, and materials
- Commercial leases
- Employee compensation payments that appear to be outliers or high-risk transactions as identified through Computer Assisted Auditing Techniques

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at <u>www.ofm.wa.gov</u>.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

Performance audits

Initiative 900, approved by voters in 2005, gives the State Auditor's Office the authority to conduct independent performance audits of state and local government entities. Performance audits may include objective analysis on ways to improve program performance and operations, reduce costs and identify best practices.

INFORMATION ABOUT THE DEPARTMENT

Created in 1957, the role of the Washington State Department of Natural Resources is to protect and manage more than 5.6 million acress of forest, range, agricultural, aquatic, and commercial lands for Washington citizens. Nearly three million acress are state trust lands, most of which were given to Washington at statehood by the federal government. State trust lands are managed by the Department to help support public schools, state institutions, and county services. Departmentmanaged lands provide many other public benefits, such as destinations for outdoor recreation, environmental protection, and healthy forests. The Department also protects natural resources through fire prevention and suppression and regulating forest practices.

For the audit period, the Department employed 1,432 permanent employees as of June 30, 2023, and more than 435 seasonal employees. Elected Commissioner of Public Lands, Hilary Franz, heads the Department. For the 2021-2023 biennium, the Department had operating budgets of approximately \$478 million.
