## AUDIT RESULTS

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to annual report filing that we communicated to District management and the Board of Directors in a letter dated November 14, 2024. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Yakima Regional Public Facilities District from January 1, 2021 through December 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2023, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Annual report filing timeliness and completeness
- Treasure's activities bank reconciliations
- Compliance with management service contract
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### INFORMATION ABOUT THE DISTRICT

The Yakima Regional Public Facilities District was created by an inter-local agreement between the cities of Yakima, Selah and Union Gap. This agreement specifies projects that will be constructed or acquired as well as how much in local sales tax will be allocated for projects.

The District is governed by a seven-member Board composed of members appointed by the three jurisdictions. The District has no paid staff members. The City of Yakima performs the accounting and administrative functions of the District. The District operates on annual revenues of \$2.1 million.
