AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to procurement that we communicated to District management and the Board of Commissioners in a letter dated December 3, 2024. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Gig Harbor Fire & Medic One from January 1, 2022 through December 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2023 and 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement public works, cooperative purchases and professional services
- Accounts payable general disbursements, credit cards and employee reimbursements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE DISTRICT

Pierce County Fire Protection District No. 5, doing business as Gig Harbor Fire & Medic One, provides fire protection and prevention and emergency medical services. The District's service area covers 54 square miles and serves a population of approximately 51,677 citizens.

An elected, five-member Board of Commissioners governs the District and appoints a Fire Chief to oversee the District's operations. The District has 138 full-time employees. Funded primarily through property taxes, the District received approximately \$43.6 million in revenue for 2023, and \$32.8 million for 2022.
