AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Authority operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Columbia County Public Transportation from January 1, 2021 through December 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Authority's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2023, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Payroll gross wages, overtime, leave cash outs, bonus and incentive payments, and final pay to departing employees
- Accounts payable general disbursements
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the Authority's major federal program, which is listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE AUTHORITY

The Columbia County Public Transportation (or CCPT) was created in 2005 when it separated as a component of Columbia County into its own, separately governed entity. It is governed by a five-member Board of Directors, made up of representatives from local entities.

The Authority provides public transportation services to about 3,950 citizens in the city of Dayton, town of Starbuck and rural Columbia County. The Authority had operating revenues of \$2,131,736 in 2023, \$2,023,012 in 2022, and \$1,297,370 in 2021 respectively. The Authority had operating expenditures of \$1,670,346 in 2023, \$1,509,478 in 2022, and \$1,261,028 in 2021 respectively. The Authority has 15 employees.
