# AUDIT RESULTS

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, County operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to Open Public Meeting requirements that we communicated to County management and the Board of Commissioners in a letter dated January 8, 2025. We appreciate the County's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of Kitsap County from January 1, 2023 through December 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the County's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements, credit cards, travel expenditures and employee reimbursements
- Auditor's Office cash receipting and elections
- Assessor's Office property tax valuations, exemptions, new construction appraisals and report submissions
- Juvenile Detention Center detainee property, billing to other jurisdictions for detention services and tracking and monitoring of gift cards

- Procurement public works, cooperative purchases, exemptions and professional services
- Equipment rental and replacement establishment of rates and billing accuracy
- Use of restricted funds sales and use tax for chemical dependency and housing services
- Tracking and monitoring of fuel use
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### **Financial**

Our opinion on the County's financial statements and compliance with federal grant program requirements is provided in a separate report, which includes the County's financial statements. That report includes a finding for a material weakness in internal controls over financial reporting regarding financial statement preparation.

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the County's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. ### INFORMATION ABOUT THE COUNTY

Kitsap County was formed in 1857 from parts of King and Jefferson counties and includes four incorporated cities: Bremerton, Bainbridge Island, Poulsbo and Port Orchard. The County is home to Puget Sound Naval Shipyard, Naval Base Kitsap, and the Keyport Undersea Warfare Research Station. It serves approximately 283,000 citizens.

The County is governed by a three-member Board of Commissioners, elected by district voters to four-year, staggered terms. Additional elected officials help administer the County including Assessor, Auditor, Clerk, Prosecutor, Sheriff, Treasurer and judges for the District and Superior Courts. The County has approximately 1,250 employees. The County provides some services on a countywide basis and some services only to unincorporated areas. Services include road construction and maintenance, flood control, parks and recreation facilities, court services, law enforcement and criminal detention. In addition, the County provides tax assessments and collections, planning, zoning, rehabilitative services, public health care, election administration, treasury services and processing and disposing of solid and liquid wastes. The County operates on an annual budget of approximately \$548 million.
