AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Oroville-Tonasket Irrigation District from January 1, 2022 through December 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2023 and 2022, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Procurement public works and purchases
- Payroll gross wages
- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

INFORMATION ABOUT THE DISTRICT

The Oroville-Tonasket Irrigation District formed in 1916, founded from the original West Okanogan Irrigation District that had area water rights dating back to 1912. The District provides irrigation water to roughly 1,400 irrigation users in Okanogan County. The District is funded primarily through assessments based on water shares assigned to the property parcels, and secondarily through leasing of water from the District's Water Bank. For fiscal years 2022 and 2023, the District operated on annual budgets of approximately \$2 million.

An elected, five-member Board of Directors governs the District, which has nine employees.
