AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to Associated Student Body (ASB) fundraisers that we communicated to District management and the Board of Directors in a letter dated March 6, 2025. We appreciate the District's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of Lakewood School District No. 306 from September 1, 2022 through August 31, 2024.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the District's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended August 31, 2024 and 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Associated Student Body activities at Lakewood High School fundraisers, gate receipts, inventory, student store and cash receipting
- Compliance with bond debt covenants
- Accounts payable general disbursements and credit cards
- Use of restricted funds professional learning and local revenue for enrichment activities

- Compliance with supplemental contracts for enrichment activities
- Apportionment compliance with certification requirements
- Financial condition reviewing for indications of financial distress
- Open public meetings compliance with minutes, meetings and executive session requirements

INFORMATION ABOUT THE DISTRICT

Lakewood School District No. 306 provides school services to approximately 2,600 students from preschool/transition to kindergarten through 12th grade. The District is located in northwestern Snohomish County and includes Smokey Point and the Seven Lakes area between the cities of Arlington, Marysville and Stanwood. The District has one high school, one middle school and three elementary schools.

An elected, five-member Board of Directors governs the District. The Board appoints a Superintendent to oversee the District's daily operations and its staff of approximately 400 certificated and classified employees. The District's expenditures for fiscal year 2024 were \$48,439,197.
