## **AUDIT RESULTS**

#### Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, College operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to student fees and scholarship awards that we communicated to College management and the Board of Trustees in a letter dated March 27, 2025. We appreciate the College's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Grays Harbor College from July 1, 2020 through June 30, 2024.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the College's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2024, 2023, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Compliance with grant eligibility requirements
- Tuition and fees
- Compliance with financial aid and scholarship eligibility requirements
- Accounts payable purchase cards
- Cash receipting timeliness and completeness of deposits, voids and adjustments, and physical safeguards
- Open public meetings compliance with minutes, meetings and executive session requirements

#### **RELATED REPORTS**

#### Financial

Our opinion on the College's basic financial statements is provided in a separate report, which includes the College's financial statements. That report is available on our website, <a href="http://portal.sao.wa.gov/ReportSearch">http://portal.sao.wa.gov/ReportSearch</a>.

We also perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at <a href="https://www.ofm.wa.gov">www.ofm.wa.gov</a>.

#### Federal grant programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

## INFORMATION ABOUT THE COLLEGE

Grays Harbor College was incorporated on August 7, 1930, and became part of the state higher education system on July 1, 1967. In addition to the main campus there are Education Centers in Raymond and Ilwaco. The College's mission statement states that Grays Harbor College provides meaningful and engaging learning opportunities and support services to enhance the knowledge, skills, and abilities of our students and support the cultural and economic needs of our community.

The College and its approximately 170 full-time staff carry out this mission by providing programs in:

- Academic transfer courses
- Basic education, literacy and academic skill development
- Occupational, technical and professional preparation and training
- Services and activities designed to facilitate student success
- Cultural enrichment, intellectual inquiry and information services.

The College operates on an annual budget of approximately \$23 million and is governed by a five-member Board of Trustees. The Board is appointed by the Governor for five-year terms.
