AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, College operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to the Walla Walla Community College Foundation agreement that we communicated to College management and the Board of Trustees in a letter dated April 3, 2025. We appreciate the College's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Walla Walla Community College from July 1, 2020 through June 30, 2024.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the College's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2024, 2023, 2022 and 2021, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Compliance with the Walla Walla Community College Foundation agreement terms
- Contract compliance – cash receipting and deposit timeliness at the bookstore; tracking and reconciling commission payments from third party vendor
- Payroll – gross wages, bonus and incentive payments
- Financial Aid - federal Pell grant, federal supplemental educational opportunity grant, Washington college grant
- Accounts payable – general disbursements
- Open public meetings – compliance with minutes, meetings and executive session requirements
- Financial condition – reviewing for indications of financial distress

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at www.ofm.wa.gov.

Our opinion on the College's basic financial statements is included in the College's separate Annual Comprehensive Financial Report.

Federal grant programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

INFORMATION ABOUT THE COLLEGE

Walla Walla Community College is a state-supported school that was founded in 1967 and currently serves about 6,500 students each year. The College is one of 34 community and technical colleges in the state. The College serves Walla Walla, Garfield, Asotin and Columbia counties and includes a branch campus in the City of Clarkston. The College operates on an annual budget of about \$38 million and has about 510 employees.

A five-member Board of Trustees, appointed by the Governor, is responsible for oversight of College operations. Chad E. Hickox has served as the Community College's President since May 2020.
