#### **AUDIT RESULTS**

#### **Results in brief**

This report describes the overall results and conclusions for the areas we examined. In those selected areas, University operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

However, we noted certain matters related to procurement addressed in the management letter that we communicated to University management and the Board of Trustees in a letter dated May 15, 2025. We appreciate the University's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

#### About the audit

This report contains the results of our independent accountability audit of the Western Washington University from July 1, 2022 through June 30, 2024.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the University's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2024 and 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Local funds investment activity and bank reconciliations
- Student Business Office cash receipting
- Facilities Department safeguarding, tracking and monitoring of theft sensitive assets, such as vehicles, computers, tools, equipment, and fuel
- Procurement purchasing exemptions
- Conflict of interest procurement of service contracts

- Open public meetings compliance with minutes, meetings and executive session requirements
- Financial condition reviewing for indications of financial distress

#### **RELATED REPORTS**

#### Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at <u>www.ofm.wa.gov</u>.

#### **Federal programs**

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

#### **Performance audits**

Initiative 900, approved by voters in 2005, gives the State Auditor's Office the authority to conduct independent performance audits of state and local government entities. Performance audits may include objective analysis on ways to improve program performance and operations, reduce costs and identify best practices.

#### **INFORMATION ABOUT THE UNIVERSITY**

Western Washington University, formerly Western Washington State College, achieved university status in 1977. Located in the city of Bellingham, the University serves approximately 15,000 students each quarter with approximately 1,800 permanent employees.

An eight-member Board of Trustees, appointed by the Governor and confirmed by the Senate, is responsible for oversight of University operations. Dr. Sabah Randhawa became the University's 14th President on August 1, 2016.

The University's operating revenues for the 2022-2023 and 2023-2024 fiscal years were \$237.7 million and \$242.6 million. The major sources of revenue for the University include student tuition and fees, as well as state appropriations.
