AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Agency operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Washington State Patrol from July 1, 2022 through June 30, 2024.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the Agency's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended June 30, 2024 and 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Firearms background check program implementation and revenue collection
- Overtime expenditures use, tracking, and documentation of overtime expenditures
- Travel expenditures use, tracking, and documentation of travel expenditures
- Vendor disbursements use, tracking, and documentation of vendor expenditures

RELATED REPORTS

Financial

We perform an annual audit of the statewide basic financial statements, as required by state law (RCW 43.09.310). Our opinion on these financial statements is included in the Annual Comprehensive Financial Report (ACFR). The ACFR reflects the financial activities of all funds, organizations, agencies, departments and offices that are part of the state's reporting entity. The results of that audit are published in a report issued by the Office of Financial Management in December of each year and can be found at <u>www.ofm.wa.gov</u>.

Federal programs

In accordance with the Single Audit Act, we annually audit major federal programs administered by the state of Washington. Rather than perform a single audit of each agency, we audit the state as a whole. The results of that audit are published in a report issued by the Office of Financial Management in March of each year.

Performance audits

Initiative 900, approved by voters in 2005, gives the State Auditor's Office the authority to conduct independent performance audits of state and local government entities. Performance audits may include objective analysis on ways to improve program performance and operations, reduce costs and identify best practices.

INFORMATION ABOUT THE AGENCY

The Washington State Patrol provides public safety services across Washington State. These services include traffic enforcement on state highways, commercial vehicle safety and security on the state ferry system. Additional services include maintaining criminal records and criminal history databases, conducting criminal investigations, participating in narcotics task forces, providing forensic laboratory services, which include the state Crime and Toxicology laboratories, and delivering fire preparedness and prevention services through the Office of the State Fire Marshall. The Agency is based in Olympia, but has multiple offices statewide, staffed with approximately 2,400 employees. The Governor appoints the Chief of the Washington State Patrol.

For fiscal years 2023 and 2024, the Agency's operating budget was approximately \$882 million. The Agency is primarily funded by the State Patrol Highway Account, which derives its revenue from basic vehicle registration fees. In addition, the Agency has several restricted accounts with dedicated sources of revenue including fingerprint and background check fees, fire training fees, crime analysis fees, fireworks licenses and breath test fines.
