AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined related to the Pharmacy Point of Sale system's application, interface and general information technology (IT) controls. In those selected areas, controls were adequately designed and implemented to provide reasonable assurance of complete, accurate, secure and available data.

In keeping with general auditing practices, we did not examine every function or aspect of the application system. Instead, based on our audit objectives, we examined those key application, interface and general IT controls representing the highest risk to the application system's security, availability and processing integrity. Our assessment of controls related to data security was limited to electronic access to the application. Our audit was not designed to assess or provide assurance on the Authority's overall security posture.

About the audit

This report contains the results of our independent audit of the Authority's Pharmacy Point of Sale system. Our audit examined the controls in place from June 1, 2024 through June 30, 2025.

The Pharmacy Point of Sale system manages pharmacy transactions, including receiving and adjudicating claims, and processing drug rebate invoicing, all while integrating with pharmacies' front-end operations. The Authority contracted with Conduent to replace the legacy pharmacy system to align with industry standards and improve claims adjudication processes. The new Pharmacy Point of Sale system went live in June 2024.

Management is responsible for ensuring IT systems are designed, implemented and maintained to provide reasonable assurance of security, availability and processing integrity. This includes establishing controls over acquiring, developing and maintaining technology assets relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.310, which requires the Office of the Washington State Auditor to examine the financial affairs of all state agencies. Our audit involved obtaining evidence about the Pharmacy Point of Sale system's key application and interface controls, along with related general IT controls. The procedures we performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment, we examined the following areas during this audit period:

- **Application controls** related to claims and drug rebates. Application controls include input, processing and output controls. These controls are designed to ensure the data entered into, processed by and output from an information system is complete, accurate and valid.
- **General IT controls** related to change management and user access. General IT controls are designed to ensure proper development, integrity and security of system and computer operations.
