AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, City operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

Additionally, we noted certain matters related to payroll that we communicated to City management, the Mayor and City Council in a letter dated July 15, 2025. We appreciate the City's commitment to resolving those matters.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the City of Tacoma from January 1, 2023 through December 31, 2023.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the Washington State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the City's use of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the year ended December 31, 2023, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Tacoma Public Utilities and Public Works payroll gross wages
- Municipal Court credit cards, payroll gross wages and overtime
- Software conversion Enterprise Justice
- Tacoma Rail cash receipting, payroll overtime, procurement of public works and tracking and monitoring of theft sensitive assets and fuel

- Environmental Services Department payroll gross wages, accounts payable general disbursements and credit cards, procurement of public works and compliance with public works contract terms
- Public Works Department cash receipting, accounts payable credit cards, surplus of land disposition/receipt of sales proceeds and procurement of public works and purchases
- Information Technology payroll gross wages and overtime and accounts payable credit cards
- Planning and Development Services cash receipting and accounts payable credit cards
- Police Department use and tracking of confidential funds and cash receipting
- Neighborhood and Community Services use of restricted funds sales and use tax
- Financial condition reviewing for indications of financial distress
- Open public meetings compliance with minutes, meetings and executive session requirements

We evaluated internal controls and tested compliance with the federal program requirements, as applicable, for the City's major federal programs, which are listed in the Schedule of Findings and Questioned Costs section of the separate financial statement and single audit report. INFORMATION ABOUT THE CITY

The City of Tacoma serves approximately 225,100 citizens in Pierce County and is the third largest city in the state. The City operates under a council-manager form of government with nine independently elected, part-time Council Members, including the Mayor. The Mayor is the ceremonial head of the City and a member of the City Council. The Council Members choose a part-time Deputy Mayor from within the Council. The City Manager is appointed by the City Council and is responsible for daily operations of the City as well as its approximately 4,035 regular and temporary employees.

The City provides a full range of municipal services including police, Municipal Court, fire prevention and suppression, public works, planning and development, utilities, public facilities, community development, and general administrative and support services. In addition, the City owns public facilities including the Tacoma Dome, the Convention Center, Broadway Center for the Performing Arts, and Cheney Stadium.

For the 2023-2024 biennium, the City budget of approximately \$4.3 billion including \$615 million for the general fund and \$1.6 billion for the Tacoma Public Utilities. The Tacoma Metropolitan Parks District provides parks and recreation service on behalf of the City.
