#### ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Bellingham-Whatcom Public Facilities District.

We performed audit procedures to determine whether the District complied with state laws and regulations and its own policies and procedures. We also examined District management's accountability for public resources. Our work focused on specific areas that have potential for abuse and misuse of public resources.

Areas examined during the audit were selected using financial transactions from January 1, 2005, through December 31, 2006.

#### RESULTS

The District complied with state laws and regulations and its own policies and procedures in most areas we examined. Internal controls were adequate to safeguard public resources. We noted certain issues that we communicated to District management. We appreciate the District's commitment to resolving the issues.

We thank District officials and personnel for their assistance and cooperation during the audit.

## **Description of the District**

#### Bellingham-Whatcom Public Facilities District Whatcom County November 26, 2007

#### ABOUT THE DISTRICT

The Bellingham-Whatcom Public Facilities District was formed in July 2002 as a joint effort between the City of Bellingham and Whatcom County and pursuant to state legislation on the creation of regional centers. The District's mission is to fund a regional center and cultural district located in downtown Bellingham that will increase economic prosperity and lay a foundation for further public and private investment in the community.

The District is governed by a seven-member Board of Directors and an inter-local agreement between the District and the City of Bellingham. It is managed by two part-time staff members with operational support from the City and private service contracts. Expenditures in 2005 and 2006 were \$818,876 and \$1,342,443, respectively.

#### AUDIT HISTORY

We audit the District every two years. The District received one prior audit for the 2002-04 fiscal years. That audit resulted in one finding regarding a lack of supporting documentation for disbursements. The District has taken steps to resolve this issue.

## Audit Areas Examined

### Bellingham-Whatcom Public Facilities District Whatcom County November 26, 2007

In keeping with general auditing practices, we do not examine every portion of the Bellingham-Whatcom Public Facilities District's financial activities during each audit. The areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. Other areas are audited on a rotating basis over the course of several years. The following areas of the District were examined during this audit period:

### ACCOUNTABILITY

We evaluated the District's accountability and compliance with laws, regulations, contracts and grant agreements in the following areas:

- Contracts/agreements
- Parking services
- Open public meetings/records laws
- Disbursements/expenditures
- Conflict of interest/ethics laws

## **Status of Prior Audit Findings**

#### Bellingham-Whatcom Public Facilities District Whatcom County November 26, 2007

The status of findings contained in the prior years' audit reports of the Bellingham-Whatcom Public Facilities District is provided below:

**1.** The Bellingham-Whatcom Public Facilities District did not comply with state law when it awarded payments to three design competition finalists.

Report No. 70948, dated 4/14/2006

#### Background

The District sponsored a competition to select a design and architectural team for a new children's museum and art museum. Three finalists were selected and each received a payment of \$10,000. At the time the payment was made, it was unclear what services had been received by the District. State law requires goods or services to be provided prior to payment. The District did not clearly document in advance of the payments what services were being provided.

#### <u>Status</u>

We reviewed the District's procurement process and disbursements. Based on the District's steps to ensure compliance with bid laws and provide supporting documentation for all disbursements, we consider the finding resolved.
