ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Town of Malden.

We performed audit procedures to determine whether the Town complied with state laws and regulations and its own policies and procedures. We also examined Town management's accountability for public resources. Our work focused on specific areas that have potential for abuse and misuse of public resources.

Areas examined during the audit were selected using financial transactions from January 1, 2004, through December 31, 2005.

RESULTS

In most areas, the Town complied with state laws and regulations and its own policies and procedures. The Town generally had sufficient internal controls in place to safeguard public resources. However, we noted certain issues that we communicated to Town management. We appreciate the Town's commitment to resolving the issues.

We also found the Town made progress in resolving the weaknesses identified in prior audits. One finding was resolved and the second one was partially resolved.

CLOSING REMARKS

We thank Town officials and personnel for their assistance and cooperation during the audit.

ABOUT THE TOWN

The Town of Malden serves approximately 215 citizens in Whitman County. The Town operates under a mayor-council form of government with a five-member Council and an independently elected Mayor.

The Town operated on an annual budget of \$110,030 during 2004 and \$107,100 during 2005. The Town employs one person and provides an array of services including public safety, general administrative, parks and recreation, street improvement and water services.

AUDIT HISTORY

We audit the Town every two years. The prior audit of the Town reported two findings. The Town did not comply with budget requirements or properly monitor financial activity. The Town also authorized and paid extra compensation to employees. The Town has taken steps to make improvements and correct conditions noted in these findings.

In keeping with general auditing practices, we do not examine every portion of the Town of Malden's financial activities during each audit. The areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. Other areas are audited on a rotating basis over the course of several years.
