Audit Summary

Inter Island Medical Center and San Juan Emergency Medical Services San Juan County March 5, 2014

ABOUT THE AUDIT

This report contains the results of our independent accountability audit of the Inter Island Medical Center and San Juan Emergency Medical Services from January 1, 2011 through December 31, 2012.

We evaluated internal controls and performed audit procedures on the activities of the District. We also determined whether the District complied with state laws and regulations and its own policies and procedures.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of noncompliance, misappropriation or misuse. The following areas were examined during this audit period:

- Financial condition
- Payroll/benefits

- Disbursements/credit cards
- Contracts/agreements

RESULTS

In most areas, the District complied with state laws and regulations and its own policies and procedures.

However, we noted certain matters that we communicated to District management. We appreciate the District's commitment to resolving those matters.

ABOUT THE DISTRICT

San Juan County Public Hospital District No. 1 was incorporated in 1990 and is currently doing business as Inter Island Medical Center and San Juan Island Emergency Medical Services. The District operates a combined medical clinic and hospital and also operates San Juan Emergency Medical Services / Island Air Ambulance, which provides emergency medical services, critical care transport, and injury and accident prevention programs. The District boundaries include San Juan Island, Brown Island, Stuart Island, Johns Island, Speiden Island, Pearl Island and Henry Island.

An elected, five-member Board of Commissioners governs the District. The District appoints management to oversee its approximately 35 employees. The District operated on an annual budget of approximately \$5 million in 2011 and \$6 million in 2012.

AUDIT HISTORY

We audit the District every two years. The fiscal year 2010 audit contained a finding related to financial position and risk of not being able to maintain services. This finding has been resolved. No findings were reported in the current audit.

Status of Prior Audit Findings

Inter Island Medical Center and San Juan Emergency Medical Services San Juan County March 5, 2014

The status of findings contained in the prior years' audit reports of the Inter Island Medical Center and San Juan Emergency Medical Services is provided below:

1. The Inter Island Medical Center's financial position leaves it at risk of not being able to maintain services.

Report No. 1007280, dated February 27, 2012

Background

The District operates San Juan Island Emergency Medical Services and Inter Island Medical Center. During 2008 through 2011, the District's expenditures exceeded revenue, forcing the District to obtain a line of credit. The decrease in revenue began in 2008 when the medical center experienced a large amount of physician turnover and steadily increasing operational costs.

Status

The condition reported during the 2010 audit has been resolved. For fiscal year 2012, the District's expenditures no longer exceed revenue due to a nonprofit organization taking over operations of the medical center and the District paying off the line of credit.
