Prior to July 1, 2009, the Central Valley Ambulance Authority was a part of Skagit County Emergency Medical Services. The Authority is a component unit of Skagit County, doing business as Central Skagit Medic One. The Authority has 32 employees and provides emergency medical and related services to citizens in the Central Skagit Valley. An appointed, seven-member Board of Representatives governs the Authority as well as approves its bylaws and annual budget. For fiscal year 2013, the Authority operated on an annual budget of \$4.3 million.

We audit the Authority on an annual basis. There has been one finding reported during the last four audits. The fiscal year 2010 audit reported a finding for noncompliance with bid law. That finding was resolved. There were no findings reported during the current audit.
