AUDIT SUMMARY

Results in brief

In the areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

About the audit

This report contains the results of our independent accountability audit of the City of Orting from January 1, 2011 through December 31, 2013.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement (bidding/prevaling wage)
- Police financial operations/custody of evidence
- Court financial operations
- Payments/expenditures
- Financial condition

Our opinion on the City's financial statements is provided in a separate report, which includes the City's financial statements.

INFORMATION ABOUT THE CITY

The City of Orting serves 7,050 citizens in Pierce County. It is administered by a mayor-council form of government. The City has seven elected Council Members and an independently elected Mayor. The Council appoints an Administrator to oversee the City's daily operations as well as its 33 employees. The City provides services including water, sewer, stormwater, police protection, Municipal Court, parks and recreation, building permitting and land use, planning and economic development. For fiscal years 2011, 2012 and 2013, the City operated on annual budgets of approximately \$13.5 million, \$19.3 million and \$27.9 million, respectively.
