AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated December 8, 2015, related to the City's financial condition. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Oakville from January 1, 2013 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open public meetings
- General revenue and expenditures
- Key system controls
- Financial condition
- Cash receipting
- Cost allocation
- Payroll
- Contracts and agreements
- Small and attractive assets

INFORMATION ABOUT THE CITY

The City of Oakville serves approximately 715 citizens in Grays Harbor County. The City provides its citizens an array of services including public safety, Municipal Court, cemetery, a water utility, street infrastructure and maintenance and general administrative services.

An elected, five-member Council and an independently elected Mayor govern the City. The Council appoints management to oversee the City's daily operations, as well as its four employees. In fiscal years 2013 and 2014, the City operated on annual budgets of approximately \$800,000.
