## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Coupeville Library Capital Facility District from January 1, 2012 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Financial condition
- Open Public Meetings Act compliance
- Procurement (bidding/prevaling wage)
- General disbursements
- Bond payments

## INFORMATION ABOUT THE DISTRICT

The Coupeville Library Capital Facility District was established in 2008 to serve the City of Coupeville and portions of unincorporated Island County, serving more than 10,000 citizens. The District is a special purpose local government established to issue bonds to finance the acquisition of the Coupeville Library from the Town of Coupeville, the remodeling, expansion, furnishing and equipping thereof, and to levy the related excess taxes to pay the bonds.

The District is governed by an appointed, three-member Board consisting of three Island County Commissioners and has no employees. The Coupeville Library is owned and operated under an interlocal agreement by Sno-Isle Libraries who also serves as the fiscal agent for the District. In fiscal years 2012, 2013, and 2014, the District had expenditures of \$182,238, \$184,180, and \$342,661, respectively. The District will continue to levy excess taxes for bond debt service until the bonds mature in 2028.
