AUDIT SUMMARY

Results in brief

In most areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

However, we noted certain matters that we communicated to District management in a letter dated February 23, 2016, related to the District's financial condition. We appreciate the District's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the Evergreen Health Monroe from January 1, 2014 through December 31, 2014.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act compliance
- Bid law/procurement (prior issue follow-up)
- Alliance Governance Board (AGB) interlocal agreement review
- Financial condition
- Payroll disbursements
- Small and attractive assets (prior issue follow-up)

Financial

A financial statement audit was performed by a firm of certified public accountants. That firm's report is available from Evergreen Health Monroe.

INFORMATION ABOUT THE DISTRICT

Public Hospital District No. 1 of Snohomish County (formerly Valley General Hospital), doing business as Evergreen Health Monroe, operates a hospital and other health care facilities for residents of Monroe and surrounding communities in Snohomish County. The District's primary operations include the Hospital, an acute care hospital, and the Evergreen Health Monroe Recovery Center. The Hospital is licensed for 72 acute beds and the Recovery Center is licensed for 8 detox and 32 residential treatment facility beds.

An elected, five-member Board of Commissioners governs the District. Board Members serve staggered, six-year terms. The Board appoints management to oversee the District's daily operations, as well as its approximately 362 employees. In 2014, the District had operating expenses of \$39,780,203.
