## AUDIT SUMMARY

### Results in brief

In the areas we audited, District operations complied with applicable requirements and provided adequate safeguarding of public resources. The District also complied with state laws and regulations and its own policies and procedures in the areas we examined.

### About the audit

This report contains the results of our independent accountability audit of the Point Roberts Transportation Benefit District from January 1, 2014 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Open Public Meetings Act
- Fuel tax revenues

## INFORMATION ABOUT THE DISTRICT

Point Roberts Transportation Benefit District is a separate legal entity created by Whatcom County in July 1991, under RCW 36.73, for the purpose of financing Point Roberts transportation related activities.

The County Council serves as the governing board of the District. The District's only activity is to collect a \$0.01 per gallon tax on gasoline sales within the boundaries of the District. The tax is collected by the County on the District's behalf and is used for transportation purposes within the District as allowed by RCW 36.73. The District reported no operating expenditures in 2014, 2015 and 2016.
