AUDIT SUMMARY

Results in brief

In most areas we audited, City operations complied with applicable requirements and provided adequate safeguarding of public resources. The City also complied with state laws and regulations and its own policies and procedures in most areas we examined.

However, we noted certain matters that we communicated to City management in a letter dated November 8, 2017, related to small and attractive assets and procurement. We appreciate the City's commitment to resolving those matters.

About the audit

This report contains the results of our independent accountability audit of the City of Mukilteo from January 1, 2016 through December 31, 2016.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

Our audit involved performing procedures to obtain evidence about the City's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Cost allocation – management letter follow-up
- Procurement system review
- Police – safeguarding of evidence
- Safeguarding of small and attractive assets – management letter follow-up
- Travel expenditures – management letter follow-up

INFORMATION ABOUT THE CITY

The City of Mukilteo was incorporated in 1947 and currently serves approximately 21,400 citizens in Snohomish County.

It is administered by a mayor-council form of government. The City has seven elected Council Members and an independently elected Mayor. The Mayor appoints management to oversee the City's daily operations as well as its 113 employees. For fiscal year 2016, the City operated on a \$31.9 million annual budget. The City provides a variety of services including police and fire protection, emergency medical services, street maintenance, surface water management, planning and zoning, parks and recreation and general government services.
