AUDIT RESULTS

Results in brief

This report describes the overall results and conclusions for the areas we examined. In those selected areas, Port operations complied, in all material respects, with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

In keeping with general auditing practices, we do not examine every transaction, activity, policy, internal control, or area. As a result, no information is provided on the areas that were not examined.

About the audit

This report contains the results of our independent accountability audit of the Port of Woodland from January 1, 2017 through December 31, 2019.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved obtaining evidence about the Port's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters. The procedures performed were based on our assessment of risks in the areas we examined.

Based on our risk assessment for the years ended December 31, 2019, 2018 and 2017, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. We examined the following areas during this audit period:

- Accounts payable general disbursements and electronic funds transfers
- Payroll gross wages, leave cash outs, and electronic funds transfers
- Self-insurance for unemployment
- Procurement public works
- Compliance with public works projects prevailing wages, change orders, retainage requirements
- Tenant lease compliance with contract terms

INFORMATION ABOUT THE PORT

The Port of Woodland, located in Cowlitz County, was formed in 1961. The Port has two current industrial parks occupied by 18 tenants that lease land or building space. Additional assets include one 12-acre and one 16-acre future industrial parks and approximately 350 acres of undeveloped waterfront property.

An elected, three-member Board of Commissioners governs the Port and appoints an Executive Director to oversee the daily business and the Port's six employees. Tax receipts and lease revenues are the primary sources of the Port's revenues. Tax revenues are collected and distributed directly by the Cowlitz County Treasurer's Office. The Port's annual revenues total approximately \$1.47 million, \$1.02 million and \$1.37 million for fiscal years 2017, 2018 and 2019, respectively.
